Parent and Guardian Permission Terms

As a parent/guardian I understand:

- Attendance at all classes and rehearsals is vital. If my daughter is absent, prior written notice must be provided to the Dance Coordinator Jenna Skepper, [jskepper1@mlcsyd.nsw.edu.au](mailto:jskepper1@mlcsyd.nsw.edu.au)
- The School accepts responsibility for reasonable care of students in the appropriate circumstances, however, parents/guardians are expected to accept responsibility for any injury or loss otherwise arising.
- After initial registration in a Dance class for 2021, no further online registration is necessary. Should my daughter wish to discontinue with a Dance class, written notice must be provided to the Dance Coordinator by week 7 the term prior.
- by week seven the term prior. Term fees are paid in advance for the upcoming term and may be charged to my daughter's school fees if inadequate notice is provided.
- All students must be registered as an After School Care casual (minimum) to avoid disruptions to the running and operation of the Dance program caused by late collection from classes.
- It is the parent/guardian's responsibility to provide necessary details to the Dance coordinator regarding pick up and drop off to after-school-care, on the afternoon of my daughter's lessons. I understand Dance staff facilitate back-to-back classes and cannot escort students to other Co-curricular programs around campus.
- Should a student remain uncollected after the completion of their lesson, Dance staff will provide a 10-minute grace period before escorting the student to after school care at the parent/guardian's expense.
- Dance attire including appropriate dance footwear must be adhered to as outlined in the welcome pack released at the start of Term One. A three-week grace period will apply after classes commence.
- From time to time additional Sunday rehearsals are required for students in the Year 3 to Year 6 program. I am also aware that students participating in Hip Hop or Pom have competitions that fall on weekends. Dates of these events can be found on the term notices.
- For students in the Pre-Kindergarten to Year 2 program that runs out of Piazza Studio, parents can enjoy watching the lesson through the glass doors, however, must understand this needs to be done from a distance, so as to avoid disruptions within the class.
